Playbill Venue Management (PVM) is the holder of an On-Premises Licence and this licence is in respect to the entire Playbill Venues Managed site. As a result, PVM must be the sole dispenser and seller of alcohol onsite. PVM may permit the sampling of alcohol under strict conditions. We list these conditions as follows:

1. The Exhibitor must adhere to the responsible service of alcohol standards as set out by the Liquor Act 2007. This particularly applies to the necessity of every person involved in your promotion having NSW Responsible Service of Alcohol (RSA) accreditation. A copy of accreditation must be forwarded to Playbill Venue Management with this sampling form.
2. Alcohol management sign (below) as provided by the NSW Office of Liquor, Gaming and Racing. This signage must be displayed at each stand. [www.dgr.nsw.gov.au](http://www.dgr.nsw.gov.au)

**Sign 1 – Under 18s not to be served alcohol – all premises**



3. Persons under the age of 18 may not serve or consume alcoholic beverages.
4. Alcoholic beverage samples must not exceed 30ml, and spirit based samples must not exceed 15ml. Samples must be served in a disposable plastic cup.
5. All alcoholic beverage sampling is conducted under the supervision of the venue licensee.
6. Tasting by the Public is permitted.
7. Orders may be taken for the delivery of wine from the Exhibitors premises pursuant to the Exhibitors liquor licence.
8. It is the Exhibitors responsibility to ensure that they have the appropriate liquor licence to enable delivery of alcohol post event off site in response to a request for an order from the public.
9. No sale of any alcohol is to occur whilst on a PVM managed site under any circumstances. Credit card details may be obtained from a member of the public, however, these details must be hand written and no credit card or Eftpos transaction is to occur whilst on the Playbill site.

Please acknowledge your acceptance of these conditions by completing the information below and returning this form to PVM. These conditions will form part of the Event Licence. PVM also reserves the right to amend these conditions to ensure absolute compliance with its On-Premises Licence.
